



WHEREAS, the City Commission desires to give recognition to the contributions made by its founding families commonly referred to as "pioneers," by adding the name "Pioneer Drive" to a portion of Northeast 5th Avenue; now, therefore,

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA:

SECTION 1. That the designation of a portion of Northeast 5th Avenue lying between Atlantic Boulevard (S.R. 814) and Northeast 10th Street shall have the dual designation of "Pioneer Drive" and Northeast 5th Avenue, with Pioneer Drive to be displayed most prominently on the uppermost portion of appropriate signage.

SECTION 2. That the City Clerk is directed to forward a copy of this Resolution to Broward County, so that the County may prepare and install the appropriate signage.

SECTION 3. This Resolution shall become effective upon passage.
