

Summary of Purpose and Why:

Provided for your approval is a summary of the City's five (5) year CDBG/HOME Consolidated Strategic Plan based on the U.S. Department of Housing and Urban Development's (HUD's) five areas of concerns which are:

- a) Assesses the needs of the low and moderate income communities in the following areas:
 - (i) Decent Housing: Including the homeless, elderly and persons with special needs
 - (ii) Suitable Living Environment: Including safety and livable neighborhoods and access to quality public facilities and services
 - (iii) Expand Economic Opportunities: Including job creation and retention, public services concerned with employment and reduction of poverty.

- c) Citizen Participation Plan: to determine if changes need to be made to the previous Strategic Plan to meet current needs.

RE: Agenda Item – Consolidated Plan

The Five Year Consolidated Strategic Plan is the document submitted to the U.S. Department of Housing and Urban Development (HUD) that serves as the planning guide for entitlements funded under the Community Planning and Development (CPD) formula to include grant programs.

The Five Year Plan is a document submitted to HUD with the intention to project and identifies the comprehensive housing affordability strategy and community development needs. It provides an assessment of the housing and community development needs; a strategic plan for addressing these needs; and a specific one year Action Plan (**2010-2011**) for the use of the U.S. Department of Housing and Urban Development grants funds.

The development of this Consolidated Plan has been based, in part, on a survey OHUI sent to various non-profit housing providers. Also, as part of the consolidated plan process, jurisdictions are required to complete an analysis of impediments to fair housing choice ("analysis of impediments") report and to take actions to overcome the effects of any impediments identified through that analysis. The findings of this report will be incorporated into the Consolidated Plan.

The Consolidated Plan is required to be submitted to HUD by August 15, 2010. After approval, it will be posted on the City's website and will guide the City's housing strategy for the next five fiscal years.

It is requested that this item be placed on the Cit Commission agenda of July 27, 2010.
