A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA, APPROVING AND AUTHORIZING THE PROPER CITY OFFICIALS TO EXECUTE A LICENSE AGREEMENT BETWEEN THE CITY OF POMPANO BEACH AND POMPANO BASEBALL, INC., TO OPERATE A CONCESSION STAND AT KESTER PARK AND NORTH BROWARD PARK DURING THE 2011, 2012 AND 2013 BASEBALL SEASON AND POST SEASON GAMES; PROVIDING AN EFFECTIVE DATE.

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF POMPANO BEACH, FLORIDA:

SECTION 1. That a License Agreement between the City of Pompano Beach and Pompano Baseball, Inc., a copy of which Agreement is attached hereto and incorporated herein by reference as if set forth in full, is hereby approved.

SECTION 2. That the proper City officials are hereby authorized to execute said Agreement between the City of Pompano Beach and Pompano Baseball, Inc.

SECTION 3. This Resolution shall become effective upon passage.

LICENSE AGREEMENT

THIS AGREEMENT, made and entered into this _____ day of _____, 2011, by and between:

CITY OF POMPANO BEACH, FLORIDA, a municipal corporation of the State of Florida, hereinafter referred to as "CITY".

and

POMPANO BASEBALL, INC., a Florida corporation, hereinafter referred to as "POMPANO BASEBALL".

WHEREAS, POMPANO BASEBALL is desirous of conducting and supervising the operation of the concession located at Kester Park, Pompano Beach, Florida and the concession located at North Broward Park (Baseball Field), Florida, as a method of raising revenue for the benefit of the Pompano Baseball Program; and

WHEREAS, CITY deems such activities to be in the public interest;

NOW, THEREFORE, IT IS MUTUALLY AGREED as follows:

1. CITY hereby grants to POMPANO BASEBALL and POMPANO BASEBALL hereby accepts from the CITY, a license to conduct and supervise the operation of concessions at Kester Park and North Broward Park located in the City of Pompano Beach, Florida.

2. This License shall become effective during all home games during the 2011, 2012 and 2013 POMPANO BASEBALL season and post season games to include a two-year extension upon 90-day notification from Pompano Baseball, Inc. to the City.

3. POMPANO BASEBALL agrees to use all gross receipts raised for the sole benefit of the baseball program. Gross receipts shall include all monies, the total amount of money or equivalent of money received by the Licensee at the concession site in exchange for goods or service covered by this License Agreement except that sales or other such taxes, if any, levied directly upon the sale and remitted as such by POMPANO BASEBALL shall not be included. CITY reserves the right to require the total amount of the gross receipts be recalculated by a member of the Parks and Recreation Department of the CITY at the end of each operating day. Gross receipts shall be used for, but not limited to, banquets, trips, T-shirts, jackets and plaques for the benefit of the POMPANO BASEBALL Program.

4. POMPANO BASEBALL agrees to provide for the public, without discrimination of any kind, at the concession stand, food, drink and service of high standard, equivalent in quality and price generally furnished to the public at similar places of comparable size and scope in the CITY.

Prices of all food, beverage and merchandise sold shall be posted in a conspicuous place at the concession area or other appropriate location and state whether state sales tax is included or additional to the posted price in order to promote compliance with state sales tax regulations. Additionally, any and all prices shall be subject to approval by the City Manager or his designee; a price list is attached hereto as Exhibit "A". Temporary signs to recognize donations made to POMPANO BASEBALL will be permitted. These signs and their locations will only be permitted if agreed upon by the CITY prior to the placement of such signs.

5. POMPANO BASEBALL shall not keep, handle, sell, use or give away any alcoholic beverages of any kind or tobacco products of any kind on the licensed premises.

6. POMPANO BASEBALL agrees that it is their obligation to ensure that the concession is operating and open to the public for all home games during the 2011, 2012 and 2013 POMPANO BASEBALL season and post season games to include a two-year extension upon 90-day notification from Pompano Beach Youth Baseball, Inc. to the City. POMPANO BASEBALL further acknowledges that failure to so operate and open the concession to the public shall be deemed a default of this Agreement.

7. POMPANO BASEBALL does hereby release and agree to indemnify, defend and save harmless the CITY from and against all claims, actions, causes of actions, demands, judgments, costs, expenses and all damages of every kind and nature, incurred by or on behalf of any person or corporation whatsoever, predicated upon injury to or death of any person or loss of or damage to property of whatever ownership, and in any manner arising out of or connected with, directly or indirectly, the operation or use of the licensed premises, whether or not the incident giving rise to the injury, death, loss or damage occurs within or without the licensed premises.

8. POMPANO BASEBALL shall have insurance coverage in the amount and type of coverage as set forth in Exhibit "B" attached hereto and made a part hereof. Such policy must be kept in full force and effect during the term of this License Agreement. The CITY OF POMPANO BEACH shall be listed as an additional insured on any insurance policy required pursuant to this Agreement.

9. POMPANO BASEBALL shall use the licensed property only for the purposes of establishing and supervising the operation of its concession operation. POMPANO BASEBALL shall not permit the licensed property to be used or occupied for any other purpose.

10. POMPANO BASEBALL shall keep the licensed premises and its contents in a clean, sanitary and orderly condition at all times and shall conduct the concession strictly in accordance with all applicable County and State Health Department rules and regulations. POMPANO BASEBALL further understands and agrees that they shall be responsible for all clean up of the licensed premises and all debris and trash shall be removed immediately after each event.

11. POMPANO BASEBALL shall be subject to all applicable City, County, State and Federal laws, ordinances and regulations and shall be responsible for the payment of any and all applicable taxes.

12. It is expressly understood and agreed that this is a license to operate the concessions at Kester Park and North Broward Park (Baseball Field); Pompano Beach, Florida, under the conditions and for the purposes expressed herein, and shall not be construed to be a license to engage in any business or occupation upon the premises. Any occupational license or permit required by the CITY or any other governmental agency shall be in addition to the license hereby granted to occupy said premises.

13. It is further expressly understood and agreed that no real or personal property is leased to POMPANO BASEBALL; that POMPANO BASEBALL is a licensee and not a lessee; that POMPANO BASEBALL shall comply with each and all of the undertakings, provisions, agreements, covenants, stipulations and conditions contained herein. POMPANO BASEBALL

further acknowledges that CITY is authorizing the use of the premises “as is”, and the CITY is not responsible for furnishing any supplies, equipment or personnel necessary for the concession.

14. POMPANO BASEBALL understands and agrees that the CITY shall not be responsible in any manner for any personal property of POMPANO BASEBALL which is left in the licensed premises and POMPANO BASEBALL bears any and all risks of loss.

15. POMPANO BASEBALL shall keep a true and accurate account of all monies received and spent through the operation of the concession granted and the manner in which the funds were spent for the benefit of the POMPANO BASEBALL Program and further agree to give the CITY access at all reasonable times to all books and/or records. POMPANO BASEBALL shall designate a representative to act as a liaison between POMPANO BASEBALL and CITY and shall furnish the name, telephone number and address of the representative to the CITY upon execution of this Agreement. POMPANO BASEBALL shall preserve and make available all financial records, supporting documents, and any other documents pertinent to this Agreement for a period of three (3) years after termination of this Agreement. POMPANO BASEBALL will submit a report to the Recreation Programs Administrator showing gross receipts and all expenditures within thirty (30) days following the end of the seasons. The report shall adhere to daily statements and list each day's gross receipts shown on detailed receipt statements. Detailed receipts statements will be signed and sworn by POMPANO BASEBALL's representative in charge of concession operations and show each operating day's gross receipts by category. In addition, an itemized accounting of funds generated by this Agreement that are not spent for the benefit of POMPANO BASEBALL shall be furnished. Furthermore, any such funds generated by this Agreement that are not spent for the benefit of POMPANO BASEBALL shall either be turned over to the CITY or carried forward to

next year and designated by POMPANO BASEBALL for a future enhancement to the program, and subsequently accounted for on the next year's report of concession sales, expenses and use of funds as to how designated carry-forward funds were spent to enhance POMPANO BASEBALL's program. On termination of License Agreement, if License Agreement is not renewed, then any funds generated by the License Agreement and not spent shall be turned over to the CITY.

In addition to the annual report of concession sales and expenses as above, a copy of POMPANO BASEBALL's annual report submitted to the State of Florida Corporate Records office and also a copy of the corporation's financial statement submitted to the Internal Revenue Service shall also be sent to the CITY with the annual report of sales, concession expenses and use of funds required by the License Agreement as defined above.

16. The CITY may terminate this Agreement for cause upon ten (10) days' written notice to POMPANO BASEBALL for convenience, or upon seven (7) days' written notice upon determination that it is in the public interest to terminate this Agreement.

17. Any waiver of any breach of the covenants herein contained to be performed by POMPANO BASEBALL shall not be deemed or considered as a continuing waiver and shall not operate to bar or prevent the CITY from declaring a forfeiture for any succeeding breach either of the same condition or covenant or otherwise.

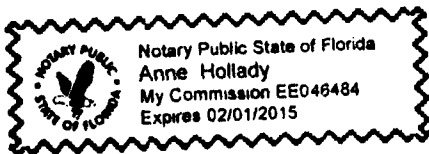
