REQUESTED COMMISSION ACTION:

SHORT TITLE OR MOTION: Approval of the First Amendment to the Continuing Contract for Architectural and Structural Engineering Services for various City projects with Currie Sowards Aguila Architects, Inc. (No cost at this time.)

Summary of Purpose and Why:

In a previous Commission action, the ranking of the top ten firms submitting on RLI H-50-10 titled "Continuing Contract for Architectural and Structural Engineering Services for Various City Projects" Currie Sowards Aguila Architects, Inc. was one of the top ranked firms. The original contract was for a one year term and the RLI provided for up to five (5) one year extensions. This is the first one year extension of the agreement.

There is no cost associated with the approval of this amendment. Work Authorizations are negotiated on a project by project basis.



THIS IS A FIRST AMENDMENT TO THE AGREEMENT dated the _____ day of _____ 2011, between:

CITY OF POMPANO BEACH, a municipal corporation of the State of Florida, whose address is 100 West Atlantic Boulevard, Pompano Beach, Florida 33060, hereinafter referred to as "CITY,"

and

CURRIE SOWARDS AGUILA ARCHITECTS, INC., a corporation authorized to do business in the State of Florida, having its office and place of business at 134 NE 1st Ave Delray Beach, Florida, 33444 hereinafter referred to as "CONSULTANT."

WHEREAS, the parties entered into a Consultant Agreement for Continuing Contract for Architectural and Structural Engineering Services for Various City Projects on November 29, 2010, ("Original Agreement"), and approved by Resolution No. 2011-57; and

WHEREAS, the CITY and CONSULTANT have agreed to extend the Original Agreement for one (1) additional one-year period;

WITNESSETH:

IN CONSIDERATION of the mutual terms, conditions, promises, covenants and payments herein set forth CITY and CONSULTANT agree as follows:

1. Each "WHEREAS" clause set forth above is true and correct and herein incorporated by this reference.
2. The original Agreement between CITY and CONSULTANT, dated November 29, 2010, a copy of which is attached hereto and made a part hereof as Exhibit "A," shall remain in full force and effect except as specifically amended hereinbelow.

3. The parties hereto agree to extend the original Agreement for one (1) additional one-year period, ending November 28, 2012.
